EN070008 - Viking CCS Pipeline

I act for Phillips 66 Limited (interested party number 20047170) ('P66') in respect of the above numbered application ('Application').

As the Examining Authority will be aware, P66 has now entered into a contractual agreement with the Applicant, among other things, which provides for the: (a) the necessary rights and land interests for the Applicant to construct and operate the Proposed Development and (b) the terms of the proposed Protective Provisions to protect Phillips 66 Limited's critical interests and operations.

Further to our Deadline 5 submission dated 5<sup>th</sup> September, we are pleased to be able to confirm that the insurance level cover error in the Protected Provisions submitted to the Examining Authority by the Applicant on 23<sup>rd</sup> August has now been rectified and an amendment agreement between the parties entered into on this basis to give effect to this agreed amendment.
