

Saved Policies of the North Lincolnshire Local Plan 2003
Updated October 2024

The North Lincolnshire Local Plan was adopted in May 2003, and later replaced by the Local Development Framework and a saved policies direction was published in September 2007. Several saved policies were superseded by the adoption of the Core Strategy Development Plan Document¹ (DPD) in 2011 and Housing and Employment Land Allocations (HELA) DPD² in 2016. This document therefore provides an up-to-date comprehensive list (as of October 2024) of saved policies from the 2003 Local Plan, with those policies superseded by the adopted Core Strategy and HELA DPDs removed.
